

#### **Coughs, Wheezes, and Respiratory Diseases**

### PURPOSE/GOALS

This is an evidence-based approach to etiology, diagnosis, and treatment of community acquired pneumonia and acute bronchitis. This presentation will explore clues to etiologic agents, identify strategies for sound antibiotic choices, and will give lots of pearls for clinical practice. The role of pneumococcal vaccine, cough suppressants, and steroids will all be discussed.

#### COURSE OBJECTIVES

- Develop an evidence-based medication plan to relieve symptoms in patients who have acute bronchitis.
- Develop an evidence-based medication plan to relieve symptoms in patients who have community acquired pneumonia.
- · Identify patients who are candidates for the pneumococcal vaccine.

#### PURPOSE/GOALS

Long term health disparities have led to persistent and often times catastrophic outcomes for all women, especially African American women. Several factors contribute, including implicit bias—an unconscious behavior pattern within our healthcare system. This session focuses on the role of the nurse practitioner in acknowledging how we may contribute to undesirable health outcomes, recognizing bias when caring for women and developing approaches to eliminate it from our interactions with the women we serve.

#### COURSE OBJECTIVES

- Discuss the role that nurse practitioner implicit bias plays in contributing to disparities within the healthcare system.
- Present specific examples of implicit bias among clinicians in women's health care.
- Identify strategies, within the primary care nurse practitioner scope of practice, to reduce implicit bias in women's health care.

Telehealth has been used in the US since 1879 when telephone and radio allowed delivery of health care remotely. In the 20th century, NASA allocated vast resources to create a way to service astronauts' health remotely. By 2016, boosted by HRSA grants, telehealth was being expanded to provide people in remote areas access to specialists. Then in 2020, a pandemic hit. Fortunately, telehealth was developed enough that health visits could be made over the internet or by telephone. Our panelists will answer your questions live in this freeform discussion.

- · Discuss current policies related to payment for telehealth.
- · Describe current drivers of growth in telehealth.
- Examine methods of performing history, physical exam remotely and documentation for reimbursement.
